- Michel Counson holds 6.46% of the company. He is still today Managing Director and CTO of EVS, in charge with the development of the XT3 platform
- Belinvest SA (controlled by Pierre L'Hoest): 4.00%. Pierre L'Hoest left the company a few weeks ago
- IMG (controlled by Laurent Minguet): 0.70%. Laurent Minguet left all executive function at EVS 7 years ago.

These notifications come after the historical shareholders' agreement between the three founders of the company ceased to apply following the departure of Pierre L'Hoest.
